#### Challenge & Refusal - It's not personal. It's the Law.

Gauging whether someone is 19 or not can be difficult – some people look – or attempt to look – older than their age. That's why the LCBO has set the bar higher with the Check 25 program. It is essential that you - as a frontline retail employee - always request ID when someone looks under 25. By following the four steps – challenge, check, evaluate and where warranted refuse – you help to ensure alcohol doesn't end up in the hands of underage teens.


#### Part 1: Prescribed ID

Part 1 of this Guide shows **all 8 types** of proof of age photo ID **prescribed** under Ontario's Liquor Licence Act:

- LCBO's BYID (Bring Your ID) Card
- Ontario Driver's Licence
- Ontario Photo Card
- Canadian Citizenship Card
- Canadian Passport
- Canadian Forces Identification Cards
- Permanent Resident Card
- Secure Certificate of Indian Status

As you know, these are the **optimal forms** of ID to rely on when you challenge someone to prove that they are of legal drinking age.


#### PART 1 - PRESCRIBED ID LCBO BYID (BRING YOUR IDENTIFICATION) CARD



Prescribed

#### Normal View

- Plastic card, not laminated
- Completely flat in texture
- Card purpose identified on front
- No raised edges



Black Light View

- Check 25 Logo displayed in ultra violet ink
- "ISSUED BY THE LCBO" text displayed in ultra violet ink



- Corporate colours and logo
- Magnetic stripe

#### PART 1 - PRESCRIBED ID ONTARIO DRIVER'S LICENCE - STANDARD ONE PIECE



- Plastic card, not laminated
- Raised lettering on the date of birth and licence number
- Actual dimensions not shown
- Includes expiry date
- Prescribed

- Older version will feature magnetic stripe on back and is valid up until expiry date
- Always check the expiry date
- May include age identifier



In some instances, customers may present a 2-piece driver's licence. (e.g. licence holder moved, renewing licence, etc.) This will include a paper document with the licence holder's personal information and their plastic Driver's licence with sticker on it indicating 'Valid Photo Only'. Customers must be able to present both the paper document and the plastic card when challenged for proof of age.

#### PART 1 - PRESCRIBED ID ONTARIO PHOTO CARD



- Clipped corner right hand side
- Purple in colour
- Raised ON CANADA lettering
- Actual dimensions not shown
- Prescribed

- Includes expiry date
- May include age identifier



NOTE: First issued July 2011 (07) No card will have an issue date prior to 2011/07

#### PART 1 - PRESCRIBED ID CANADIAN CITIZENSHIP CARD



- On February 01, 2012 a lettersized paper certificate replaced previous wallet-sized plastic cards
- The paper certificate DOES NOT include a photo
- The certificate is NOT acceptable as proof of age
- Wallet-sized cards with a DP date of 2012 02 or earlier are still valid
- If the DP date on the walletsize card is later than 2012
   02, it is likely the card has been tampered with – ask for a second form of valid government-issued photo ID; if none is available refuse the sale and record the challenge

#### PART 1 - PRESCRIBED ID CANADIAN PASSPORT

The personal information pages (pages 2 and 3) identifying the bearer include:



Digital photo, printed and embedded into the page – it also appears on the electronic chip

Personal data and signature printed and embedded in the page, cannot be removed or erased – this information is stored on the electronic chip

Holographic images embossed in the laminate to secure the information page view the images by tilting the booklet in reflected light

(4) "Optically variable ink" changes colour under different lighting

9 ePassport symbol represents that this is an ePassport containing an embedded electronic chip

6 Secondary photo appears in grey scale

See-through letters "CAN" appear when looking through the page

Machine-readable zone, with the bearer's personal information and passport details







#### In-Canada Format

- Plastic card not laminated
- Not actual dimensions shown
- First Nation Hologram on front of the card
- Prescribed
- Back displays: Not valid for border crossing into the United States of America
- Includes expiry date

#### PART 1 - PRESCRIBED ID INDIAN AND NORTHERN AFFAIRS CANADA - CERTIFICATE OF INDIAN STATUS



#### **Border-Crossing Format**

- Plastic card not laminated
- Not actual dimensions shown
- First Nation Hologram on front of the card
- Prescribed
- Back displays: Machine Readable Zone (MRZ) indicating Acceptable document when visiting the U.S. via land and water ports-of-entry
- Can be used for border crossings
- Not readable by the LCBO
- Includes expiry date

#### Part 2: Non-prescribed ID

Part 2 of this guide features the non-prescribed Ontario Health Card which may be offered to you on occasion by Ontario residents. Please remember that the Ontario Health Card needs to be treated specially. By law, it is not permissible to request that someone produce their Ontario Health card for non-health related purposes and a health number may not be collected for non-health related purposes. Never ask a customer for their Ontario Health Card. If a customer offers their health card to you voluntarily, you can accept it provided it appears to be valid.

Some customers may present you with other forms of government issued photo ID. A tourist for example may offer you a Manitoba driver's licence, or an International student may offer you a Swedish passport. These are also considered non-prescribed ID. You may accept non-prescribed ID so long as it appears to have been issued by a government, bears the person's photo, name and birth date.


For U.S. and International ID, please consult your store's copy of the United States and Canada, or International ID Check Guide.

**Fake ID is a real concern.** Please check and evaluate all ID customers present — prescribed as well as non-prescribed. If the expiry date has passed, or there is any doubt whatsoever about its validity ask the customer to provide you with another form of government-issued photo ID. If one is unavailable, refuse the sale and record the challenge and refusal on POS. Remember, as you learned in "Challenge and Refusal". It's not Personal. It's the Law", **do not confiscate suspected ID.**

- Eye colour stated
- Expiration date displayed

#### PART 2 - NON-PRESCRIBED ID NEXUS AND FAST CARD



Front face

- Plastic card, not laminated
- Optically Variable Ink can be seen in the globe image when the card is tilted
- Tactile features the boat, car and airplane icons are raised on both front and back
- Personalized print the traveler's name and DOB are printed sideways on the right side of the member's photo
- Includes an expiration date

#### Certificate of Indian Status "Pilot Project"



#### Non-prescribed:

- Issued by INAC Indian and Northern Affairs Canada
- Falls under the classification of "other" for the purpose of Challenge & Refusal
- Can be accepted if:
  - Expiry date is valid
  - Photo is a true likeness of the person presenting it
  - Bears the person's Name and DOB
- Does not appear to have been tampered with (see page 16 for more information)

#### Band Membership cards:

- Issued by a specific First Nations Band the Band name will be displayed
- Cannot be accepted on its own
- Must be accompanied with another form of valid government issued photo ID in order to be acceptable
- Easily recognizable as the wording "Band" will be written somewhere on the card
- Paper with a laminate overlay
